So he started learning santoor at the age of 13 and made Uma Dutt Sharma's dream come true. He gave his first public performance in Bombay in 1955. His first big opportunity at film music came from the Legendary Director Shantaram in 1965 with Jhanak Jhanak Payal Baaje. Besides numerous awards by various Indian organisations, he has received both the Padmashree and Padma Vibhushan from the Government of India. The Padma Vibhushan is the second highest award given to a citizen of India. He has also been extensively awarded by Western governments and has been named as honorary citizen of the city of Baltimore. He was honoured by the State of New Mexico in 2007 and in the same year was bestowed as the International Cultural Ambassador award by the World Bank

Pandit Hari Prasad Chaurasia has earned several awards, in 1992, he was awarded the Padma Bhushan and the Konarak Samman. In 1994, he was bestowed the Yash Bharati Sanman and in 2000, he was awarded the Padma Vibhushan. Pandit Hariprasad Chaurasia was born in Allahabad. His father was a wrestler. His mother dies when he was four. He had to learn music without his father's knowledge, for his father wanted him to become a wrestler. He often credits his wrestling training for giving him the immense stamina and lung power that are the hallmarks of his flute playing. He has collaborated with several western musicians, including "John McLaughlin", "Jan Gabarek", "Yehudi Menuhin" and "Jean Pierre Rampal". Panditji was honoured by the Dutch Royal family at a glittering ceremony at Amsterdam. . He has been conferred the title of Officier in the Order of Orange Nassau("officier in de Orde van Oranje-Nassau") by the Dutch Government and was honoured by Princess Maxima. He has also been honoured by the French Government and has been appointed Knight in the Order of Arts and Letter ("Chevalier de l'Ordre des Arts et des Lettres"). Churasia heads the World Music Department at the Rotterdam Music Conservatory.
